**FIRST AMENDMENT OF THE ALLOCATION AND EXPENDITURE CONTRACT FOR
THE CITY OF SACRAMENTO USING FUNDS FROM THE SMART GROWTH
INCENTIVE PROGRAM**

THIS FIRST AMENDMENT TO SACRAMENTO TRANSPORTATION AUTHORITY ALLOCATION AND EXPENDITURE CONTRACT is made and entered into this 14th day of May 2026, by and between the SACRAMENTO TRANSPORTATION AUTHORITY, a local transportation authority formed pursuant to the provisions of Public Utilities Code section 180000, et seq. (hereinafter referred to as "AUTHORITY"), and the CITY OF SACRAMENTO, a municipal corporation (hereinafter referred to as "ENTITY").

RECITALS

WHEREAS, in 2004, the electors of Sacramento County approved, by two-thirds vote, sales tax Measure 'A' and Authority Ordinance No. 04-01 ("Measure A Ordinance"); and

WHEREAS, the Measure A Ordinance includes the "Sacramento County Transportation Expenditure Plan 2009–2039" ("Expenditure Plan"); and

WHEREAS, the Expenditure Plan includes funding for projects implemented through the Smart Growth Incentive Program ("SGIP"); and

WHEREAS, AUTHORITY and ENTITY are parties to that certain Allocation and Expenditure Contract regarding SGIP projects dated March 10, 2022; and

WHEREAS, Section 4 of the Contract establishes a period of expenditure ending June 30, 2026; and

WHEREAS, the contract anticipates that an extension of the expiration date may be necessary depending on the timing of state or federal funding programmed; and

WHEREAS, AUTHORITY and ENTITY now desire to amend the Contract solely to extend the period of expenditure, with no other changes to the terms, scope, amount, or conditions of the Contract.

NOW, THEREFORE, in consideration of the conditions herein contained, AUTHORITY and ENTITY do hereby agree to amend the Contract as follows:

AGREEMENT

1. Section 4 of the Contract is amended to add an additional twelve (12) months to the length of the term, thereby changing the end date of the Period of Expenditure to June 30, 2027; and

2. All other terms and conditions not changed by this Amendment remain in full force and effect.
